### 5. Town Manager Report

- Regional Fire Services meetings held May 10 & 11, 2017; Mayor Sceviour has done media interviews.
- Fire Commissioner Derek Simmons met with elected officials and fire chiefs from all surrounding towns Brown's Arm, Laurenceton, Embree, Little Burnt Bay, Campbellton, Loon Bay, and Comfort Cove/Newstead, and Lewisporte.
- Topics discussed included Governance Model, who will govern if regional fire services are put in place, management committee to be set up with elected officials serving as members.
- Meeting to be arranged within the next week or so, by mid June all details should be finalized due to absolute deadline is July 1.
- Fire Chiefs' Roles and Responsibilities also discussed; they will meet independently from the elected officials to compile a training program for all firefighters.
- New communication system will be implemented; HiTech Communications will be here in town on Friday to go through the new digital system.
- Funding application for funding for new vehicle and equipment will be forwarded to Department of Municipal Affairs.
