# 6.5 Budget 2018

Highlights from Budget 2018 - Councillor Hooper (Finance Committee Chair):

• All rates (mil, water, etc.) remain the same.

- All existing services are maintained.
- Exploring funding options for secondary bypass road, splash pad, dog park, southside playground, etc.
- Funds allotted for resource development (attraction of offshore oil and gas companies, etc.).
- The next budget, 2019, will be prepared using a zero-based approach; all expenses must be justified for each new period. Zero-based budgeting starts from a "zero base," and every function is analyzed for its needs and costs. Budget 2019 will then be built around what is needed for the upcoming period, regardless of whether the budget is higher or lower than the previous one.
- 2018 looks to be a promising year and thanks were expressed for the input of everyone who contributed.

#### 9. Lands

#### 9.1 Development Regulations Amendment No. 23, 2016 / Adoption

The Town received an application to develop an apartment building on the east side of Main Street in the Mixed Development Land Use Zone. Condition 13 of the Mixed Development Land Use Zone Table prohibits residential development on the east side of Main Street.

The purpose of this Amendment is to amend condition 13 of the Mixed Development Land Use Zone Table to allow residential development on both sides of Main Street in the Mixed Development Land Use Zone.

During the preparation of this amendment, Council undertook the following initiatives so that individuals and groups could provide input to the proposed Development Regulations Amendment. The Town Council of Lewisporte published a notice in *The Pilot* newspaper on March 23, 2016, advertising the proposed amendment to consider comments, objections and representations from the public. The Town Council also placed the proposed amendment on display at the Town Council Office from March 23 to March 30, 2016, for residents to view and to provide any comments or concerns in writing to the Council concerning the proposed amendment. No verbal or written comments were received.

The Town of Lewisporte Development Regulations will be amended by deleting condition 13, Residential and Commercial Uses in the list of conditions in the Mixed Development as shown below:

#### 13. Residential and Commercial Uses

Residential and commercial uses permitted within Mixed Development Zone shall be located on the west side of Main Street, except for commercial uses which of necessity would be located within or attached to industrial buildings on the east side of Main Street.

And replacing with:

## 13. Residential and Commercial Uses

Residential and commercial uses shall be permitted within the Mixed Development Zone on both sides of Main Street.

# 17-269 Freake/Hooper

Under the authority of Section 16 of the Urban and Rural Planning Act 2000, the Town Council of Lewisporte adopts the Town of Lewisporte Development Regulations Amendment No. 23, 2016.

In favour: Mayor Clarke, Deputy Mayor Freake, Councillors Hooper, Hollett, Pond, Smart and Tucker. None opposed. Motion carried.

## 9.2 Development Regulations Amendment No. 26, 2017 / Adoption

The Town received an inquiry to develop a seniors' home in the area of Masonic Terrace. This area is presently zoned as Residential Medium Density. Seniors' homes are classed as special care institutional uses which is neither a permitted or discretionary use in the Residential Medium Density Lane Use Zone Table.

The purpose of the amendment is to add special care institutional uses as a discretionary use to the Residential Medium Density Land Use Zone Table, Schedule C. The amendment will also add a condition limiting special care institutional uses as homes for the aged and limiting their location to Masonic Terrace.

# 17-270 Freake/Hooper

Under the authority of Section 16 of the Urban and Rural Planning Act 2000, the Town Council of Lewisporte adopts the Town of Lewisporte Development Regulations Amendment No. 26, 2017.

#### 9.3 33-35 Stanhope Road

#### 17-271 Freake/Hooper

Whereas the Town of Lewisporte received a request to sell approximately 10,800 m<sup>2</sup> land located at 33-35 Stanhope Road for the purpose of industrial development, the exact size to be determined by a legal survey, it is resolved to sell the land pursuant to section 201.2 of the Municipalities Act, 1999, and for the un-serviced rate of \$2.69/m<sup>2</sup>. It is further resolved the purchaser shall be required to sign "The Town of Lewisporte Agreement of Purchase and Sale."
